SimSurgery will continue to market the simulators for laparoscopic and robotic surgery in the US under SimSurgery’s global brand SEP® (SimSurgery Education Platform).

“METI opened the door to the US market for SimSurgery and we are excited to begin serving this important market with a US-based team,” said Vidar Sorhus, CEO of SimSurgery. “We will continue to provide excellent sales and support service for existing and new customers and look forward to expanding our offerings around the world.”
